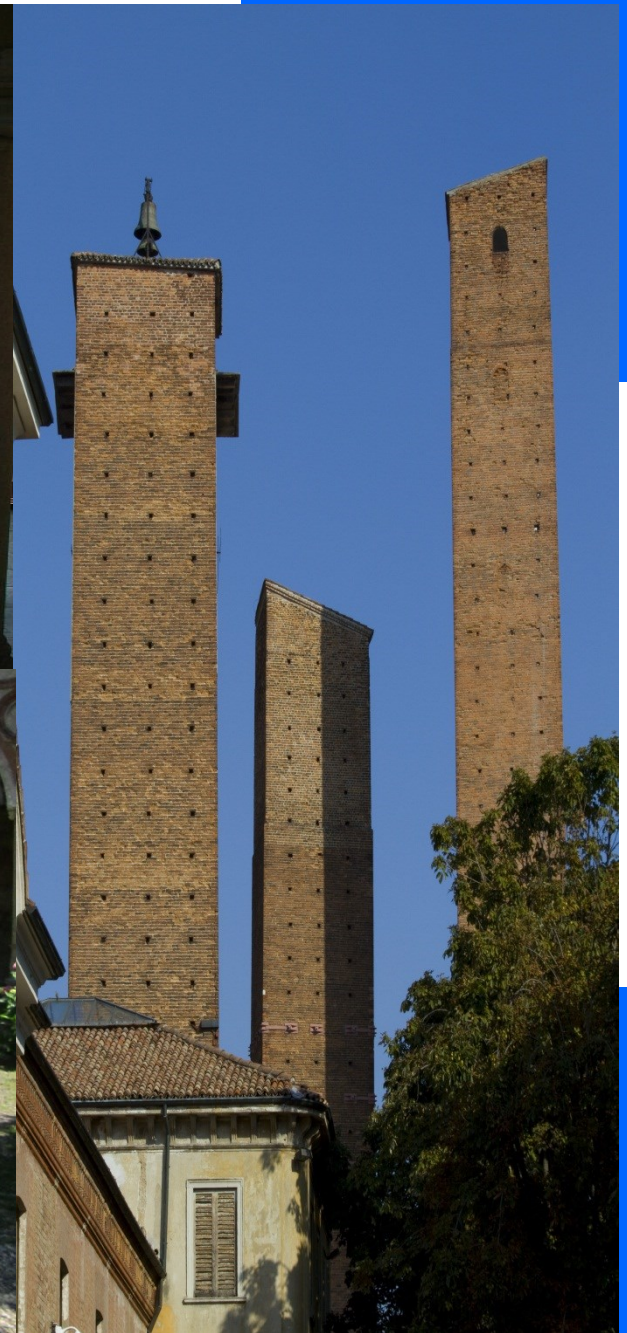

## Elective courses/internship

- In the second semester of the second year students have 12 credits of elective courses (normally two courses of 6 credits + 6 credits)
- It is possible to take an internship worth 6 credits replacing an elective course.

## Thesis guidelines

- The final thesis (worth 24 ECTS) is normally written during the second semester of the second year.
- The subject area of the thesis is normally chosen by the student who will then agree upon the specific topic together with the thesis supervisor ("relatore")
- It is advisable that the student should contact and make agreements with the supervisor in advance (normally during the first semester of the second year).

- A dedicated meeting with all details planned for November/December



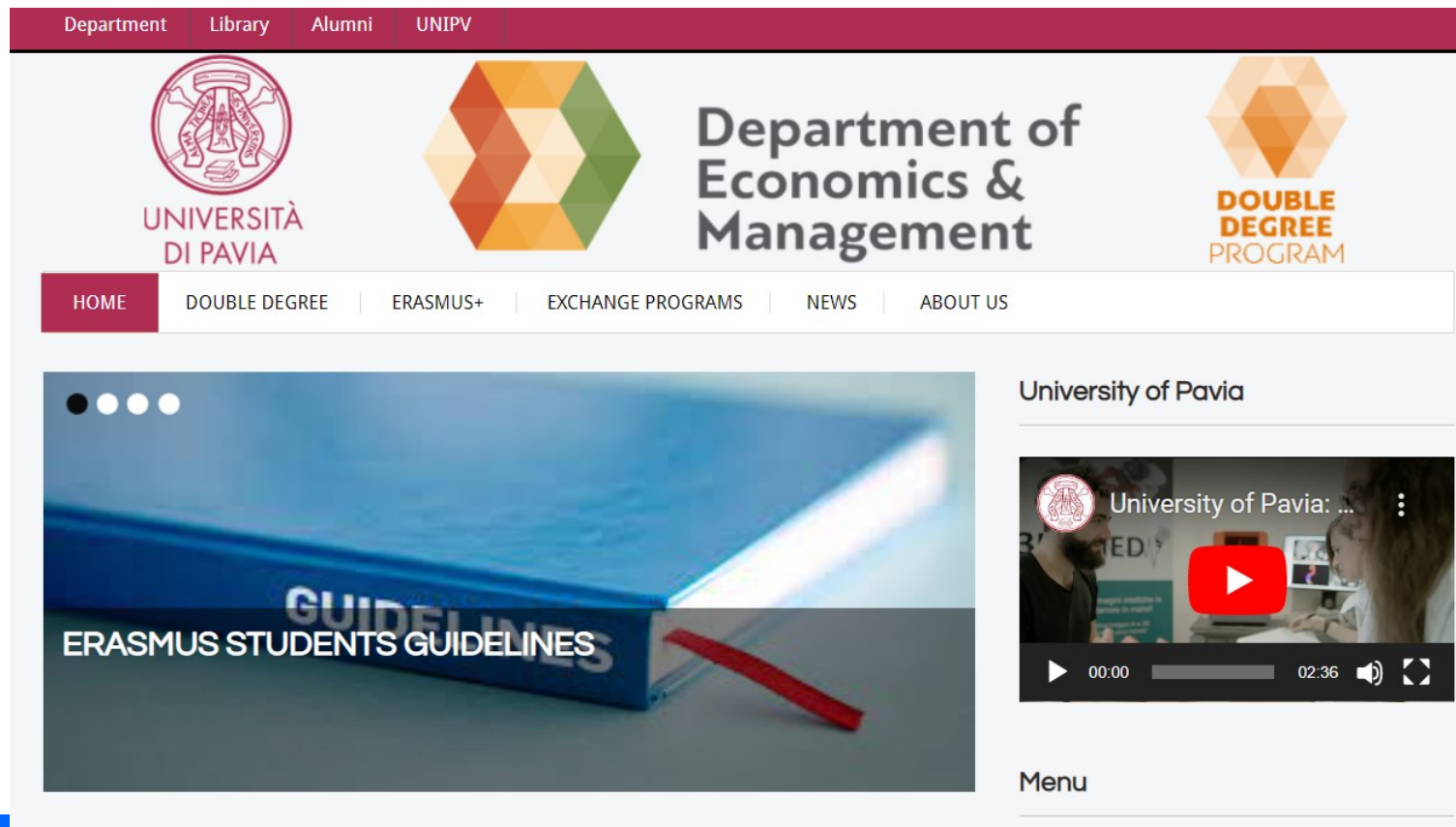

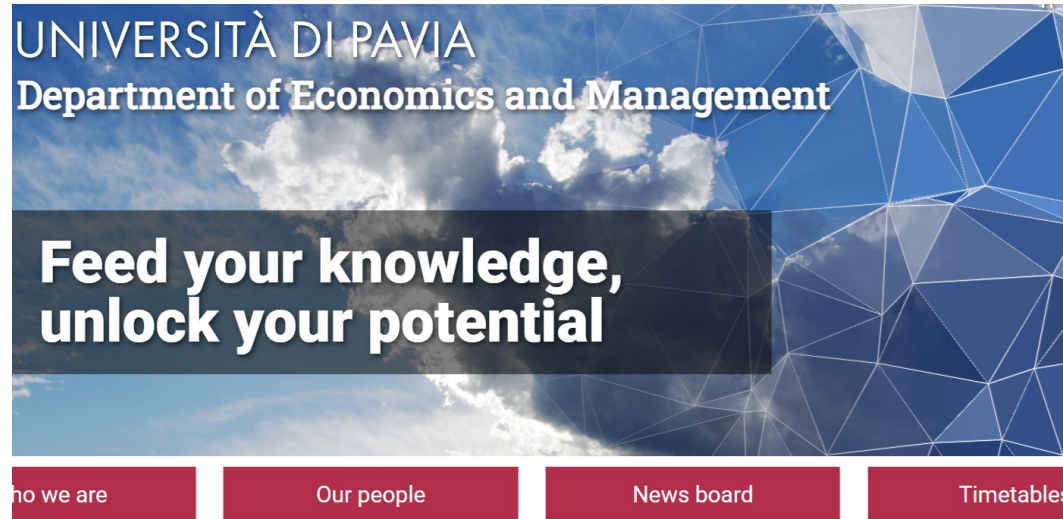

# Study plan

- **Study plan compilation**  
from 02/11/2022 to 30/11/2022
- Official choice of the MEDI curriculum
- It must be compiled for **the 1 year**
- Online, in the usual reserved area.
- If the study plan is in line with the standard one it will be automatically approved.
- Chance to add to the plan up to 24 credits of “extranumerary exams” - exams which are totally a students’ choice, extra credits added to the plan, not obligatory to take in order to graduate





# Exams

- Exams are organized in three sessions:
  - Winter (January-February) - 2 calls
  - Summer (May-July) – 3 calls
  - Fall (September) – 1 call
- Exams can be taken only after the end of the series of lectures
- Registration to the exam in the usual reserved area, normally around 2 weeks before the exam
- If an exam is failed at a given call it can be retaken at the next call of the same session and also in the subsequent session/s
- Results are published in the reserved area. If you want to refuse the mark, you can do so in the reserved area, within 5 days from the publication of results. If you accept, nothing to do: after 5 days it will be automatically registered in your career
